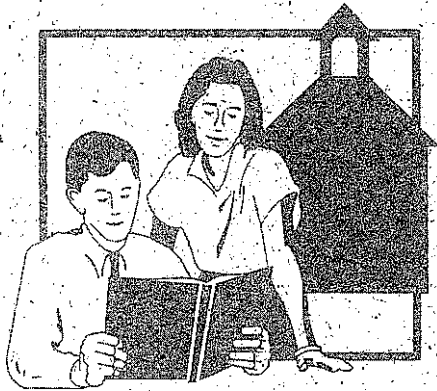
**Jeanne Allen** is President of the Center for Education Reform, a national non-profit clearinghouse for research, reform and action in education.

As a recognized authority on education reform, Allen is consulted regularly by legislators, education officials, state and national leaders. She has testified before legislatures, hosted Town Meetings, and worked with school officials on breaking reform efforts.

She appears frequently on network and cable television broadcasts, ranging from ABC's Nightline to the MacNeil-Lehrer Newshour, and her views and articles have been aired on hundreds of radio programs and in as many newspapers and journals. She is author of "The School Reform Handbook: How to Improve Your Schools."

Before founding The Center, Allen was affiliated with national think tanks, and served as an official in the U.S. Department of Education.

The purpose is to explore innovative solutions for issues by hosting a nationally recognized expert to discuss the latest information, ideas, and trends regarding the subject.

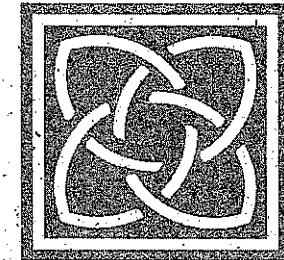
